USE INSTRUCTIONS

Spray **EUROFOUR** is once a week, or more depending on the frequency of use of the equipment, on hot surfaces (up to 100°C).

Leave act **EUROFOUR** 10 minutes (on hot surfaces) depending on the resistance of the blemishes.

Rinse thoroughly after use and ensure that all product residues and soil particles are removed.

To restore the brilliance of the outside of your furnaces and all your stainless steel, apply pure **EUROFOUR**. Rub if necessary.
