

MIDA ACTISEPT

Detergent with sanitizing properties based on a combination of glycolic solvents with an amphoteric microbicide

DESCRIPTION & APPLICATION

MIDA ACTISEPT is an innovative product that combines the disinfectant properties of the amphoteric surfactant (alkylamine) with the cleaning activity provided by a mixture of glycolic solvents and nonionic surfactants that is very effective in the removal of any kind of organic soil such as fats and proteins.

MIDA ACTISEPT is a multi-purpose detergent characterized by the following characteristic: a product effective but safe in use because it is able to clean already at a moderately alkaline pH. Its solutions are moderately foaming. Product **MIDA ACTISEPT** is characterized by an excellent and experimentally proved microbicide properties against a wide range of pathogenic microorganism: gram-positive and gram-negative bacterias and fungi.

USE INSTRUCTIONS

MIDA ACTISEPT is used at concentrations between 0,5 and 5 % (v/v) at a temperature of 30 - 50°C during a contact time between 10 and 20 min depending on the degree of soiling. Rinse with drinking water thoroughly after use and ensure that all product residues and soil particles are removed.

Suitable procedure:

1. Rinse the surface to remove the heavy soil.
2. Apply the cleaning solution.
3. Leave the product to work for the requested time.
4. Rinse carefully the surfaces with warm water.

ENVIRONMENT

MIDA ACTISEPT does not contain any chlorine and hence there is no risk of the formation of organic adsorbable halogens (AOX).

The surfactants of **MIDA ACTISEPT** comply with the European Union Directive EU648/2004 on the biodegradability of surfactants.

SAFETY

Never mix **MIDA ACTISEPT** with other products. Carefully read the material safety data sheet of **MIDA ACTISEPT** and follow the chemical handling and disposal guidance.

STORAGE

Store **MIDA ACTISEPT** in its original packaging between 5°C and 25°C. Do not expose to direct sunlight. The expiry date is 12 months from date of manufacture.

PACKAGING

MIDA ACTISEPT can be available in CAN, DRUM and IBC.
