USE INSTRUCTIONS

MIDA FOAM 165 UD is used at concentrations between 1-5% (v/v) at a temperature of 30-60°C depending on the degree and type of soiling to be removed and the water hardness. After a contact time of at least 10 to 30 min rinse thoroughly after use (within 1 hour) and ensure that all product residues and soil particles are removed.
