Chlorinated alkaline foam detergent for food and beverage industry

DESCRIPTION & APPLICATION

MIDA FOAM 2993 GJ is a chlorinated alkaline liquid detergent for sanitizing surfaces in food processing areas.

MIDA FOAM 2993 GJ is powerful in attacking and removing protein soils.

MIDA FOAM 2993 GJ is non-corrosive to 304 and 316 stainless steel.

USE INSTRUCTIONS

MIDA FOAM 2993 GJ is used by i) rinsing the surfaces to be sanitized to remove coarse dirt, ii) apply a foam based on MIDA FOAM 2993 GJ at concentrations between 0.5-5.0% (v/v) at a temperature of $30-60^{\circ}$ C depending on the degree and type of soiling to be removed and the water hardness. After a contact time of at least 10 to 20 min rinse thoroughly after use (within 1 hour) and ensure that all product residues and soil particles are removed.

MIDA FOAM 2993 GJ can be used in the manual washing of cutting boards and other equipment for the quick and complete removal of residual blood. In this application use MIDA FOAM 2993 GJ in solution at concentrations between 0,5-5,0 % (v/v) at a temperature of 30-35°C depending on the conditions of wear of the cutting boards and the soil present.

Store **MIDA FOAM 2993 GJ** in its original packaging between 5°C and 25°C. Avoid exposure to direct sunlight. The expiry date is 6 months from date of manufacture.
